Advertising

<u>Please note that the cost of advertising for a donor is not covered in our fee</u>. We firmly believe that you should have the complete freedom to advertise wherever you want and as much as you want. For that reason, although we guide and support you completely, we leave you free to contract separately with whichever media you like and pay them directly for the level of advertising that you want.

All the advertising information along with estimates of costs for doing this will be sent once you are registered. Advertising costs vary widely from about £200 for a credit-card sized advertisement in a local paper up to £1,000, or more, for a similar insertion in a national newspaper. As a ball park figure, you might therefore like to budget about £500 for this, although we try and stick within your budget, and we will help to guide you through the most appropriate places.

As a result of our drive to bring donors in, including previous advertising by other clients, we are sometimes in a position to offer you two routes for finding a donor:

1. Individual Advertising (Plan A)

The standard route is for you to undertake an individual advertising programme, based upon your personal circumstances, aimed at attracting donors directly. The costs to you in this case are:

- a. Our standard fee for helping you to find, assess and manage a donor, which is currently £1,560.00 (inc. VAT), as stated at the top of this document.
- b. Advertising costs for your individual advertisement(s). These will vary depending on where, how often and how prominent you choose. These could therefore range from about £20 to over £1,000 or more, but generally speaking you need to budget around £500, recognising that it might be more, it might be far less.

2. Pool Advertising (Plan B)

At some point, (or if you would prefer this option), we may be able to match you with a donor who has been directly recruited by or through Altrui. If this happens, and you are happy to go ahead with a donor sourced through us, we will ask you to contribute to the ongoing advertising pool.

The costs to you in this case are:

- a. Our standard fee for helping you to find, assess and manage a donor through treatment, which is currently £1,560.00 (inc. VAT), as stated at the top of this document.
- b. A nominal advertising fee of £396.00 (inc. VAT), in lieu of placing your own advertisement, to enable us to finance an ongoing advertising programme which keeps the ball rolling and donors coming in.

This would give a combination of £1,956.00 (inc. VAT) in total.



Donor Treatment Costs

You are responsible for all the medical costs for the donor, which will be organised and invoiced by the Licensed Treatment Centre directly. These vary from clinic to clinic and you can find these out from the clinic itself.

Donor Expenses

The HFEA have stated that egg donors should receive compensation of a fixed sum of £750 to cover all the costs of being a donor which should include travel, accommodation (if needed), loss of earnings and child care etc, although they have also said that in exceptional circumstances (e.g. long distance travel) they are entitled to have any extra costs covered which could be more. The transfer of any donor compensation will normally be handled by the Licensed Treatment Centre. Altrui will only manage the reimbursement of any costs with a Centre with whom we have a formal agreement and they have requested that we do so.
